Introduction

This User Manual provides instructions on how to connect the AMHxD3 On-Road / Off-Road Navigation Module to your Aerpro head unit.

The AMHxD3 has been optimised specifically for selected Aerpro head units. It is also compatible with various aftermarket head units that support CarPlay, however we cannot guarantee full functionality. It is important that you follow the connection procedure listed in this User Manual to ensure that you do not have any connection issues with the AMHxD3 and your head unit.

Make sure that your head unit has the CarPlay feature.

Ways to check if your head unit has CarPlay:

- Check with your vehicles manufacture
- Check the vehicles owners manual
- Check the head units user interface for CarPlay
- Plug in a Apple CarPlay compatible device

*Your AMHxD3 purchase includes 3 years of basic Hema Maps Cloud account access which provides you access to map downloads and data updates. Please note Data usage over and above the included amount in your Basic Subscription may incur additional charges or restrict access.




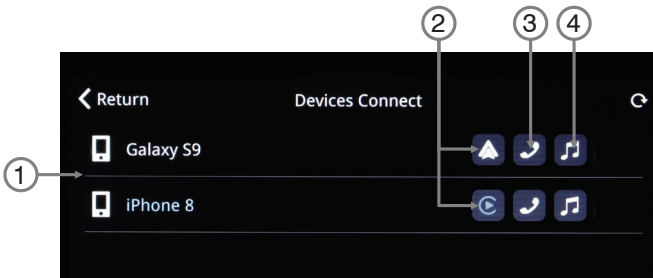
CAUTION: Do not use the factory reset in the AMHxD3 settings menu as this will remove Hema Maps and all of your saved information. If you experience any issues with the AMHxD3, disconnect and then reconnect the device from the head unit.

Procedure for AM9X & AM10X

IMPORTANT: You must disconnect any devices currently connected to the head unit before connecting the AMHxD3 to the head unit.

This procedure must be completed each time the AMHxD3 is used:

1. Turn on the head unit in the vehicle.
2. Touch the  icon to access the 'Devices Connected' screen.
3. Disconnect any devices currently connected to the head unit by simply tapping the highlighted (coloured) icons to toggle them off (see image below).

4. Connect the AMHxD3 to the USB port labelled 'CarPlay / Android Auto' on the rear of the Aerpro head unit.

5. The AMHxD3 will automatically power on and you will be presented with the home screen (refer page 8 User Interface).

6. For first time connection to the AMHxD3, navigate to your phones Bluetooth settings and select AMHxD3 (refer page 5). Your phone will now automatically connect the AMHxD3 the next time you plug the device into the head unit, as long as you have followed this procedure.

Procedure for other headunits

IMPORTANT: You must disconnect any devices currently connected to the head unit before connecting the AMHXD3 to the head unit. These steps will vary depending on the type of head unit currently installed in your vehicle. This procedure is to be used as a reference only.

This procedure must be completed each time the AMHXD3 is used:

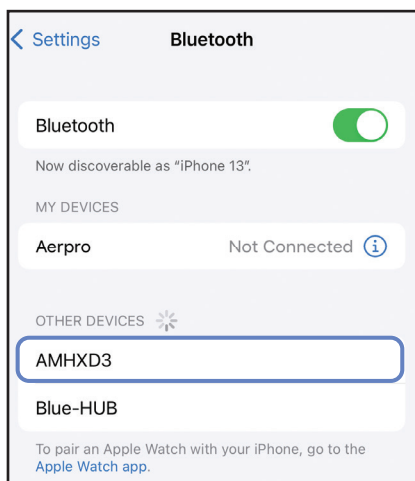
1. Turn on the head unit in the vehicle.
2. Navigate to your head units settings.
3. Tap on the Bluetooth connectivity settings.
4. Disconnect from any devices that are currently connected to your headunit.
5. Connect the AMHXD3 to the USB port labelled 'CarPlay / Android Auto' on the head unit. (Type C adapter may be required, see page 6).
6. The AMHXD3 will automatically power on and a calibration screen may appear if this is the first time it's being used on your head unit. The device will restart automatically once completed and show the home screen (refer page 8 User Interface).
7. For first time connection to the AMHXD3, navigate to your phones Bluetooth settings and select AMHXD3 (refer page 5). Your phone will now automatically connect the AMHXD3 the next time you plug the device into the head unit, as long as you have followed this procedure.



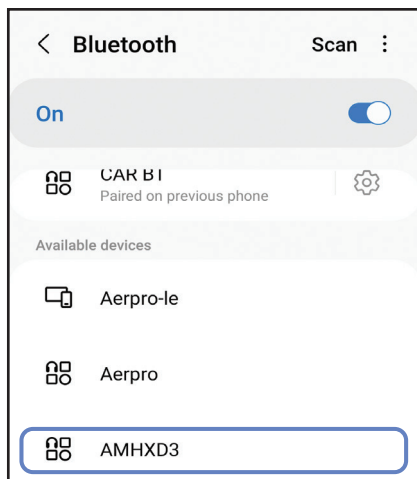

LED Indicators

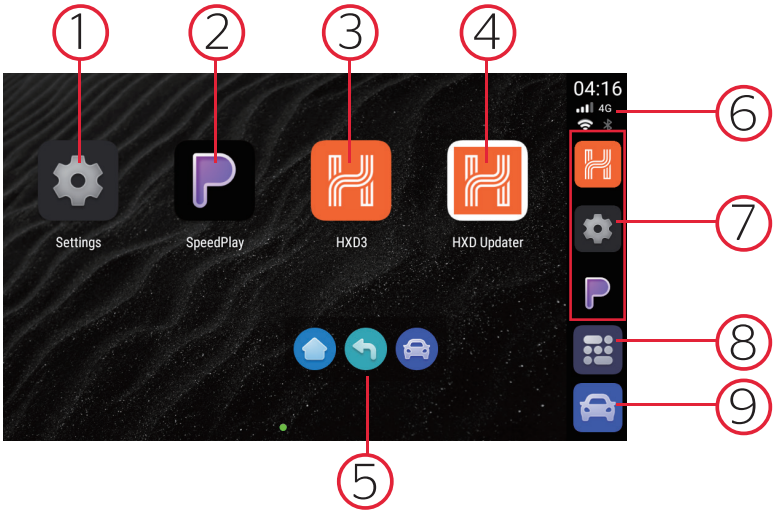


The LED indicator lights will illuminate when in active.

Hema Maps AMHXD3 Module

The Hema Maps application provides offline Turn By Turn Navigation and Off Road mapping, additional functionality and map updates are available when connecting your AMHXD3 to the internet. Refer to the Hema Maps User Guide for more information on how to use Hema Maps.

Using SpeedPlay

Since AMHXD3 uses your CarPlay USB port in your vehicle, you wouldn't be able to access the vehicles Android Auto or Apple CarPlay functionality while the AMHXD3 is connected.

Because of this, we have provided a way to retain your Android Auto or Apple CarPlay through the use of the SpeedPlay app.

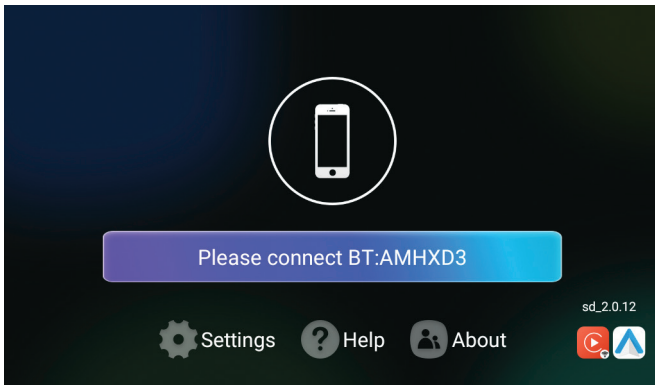
This application will allow you to use Apple CarPlay or Android Auto wirelessly by connecting your mobile device to the AMHXD3.

If you have followed the directions of connecting your Bluetooth to the AMHXD3 mentioned earlier in this manual, then all you have to do is open SpeedPlay and you will be presented with either CarPlay or Android Auto depending on your mobile device.

If this is not the case then please try restarting your mobile device and start the connection procedure again.

After first pairing, your phone will automatically connect to the AMHXD3 bluetooth and Android Auto or Apple CarPlay will show when you tap SpeedPlay.

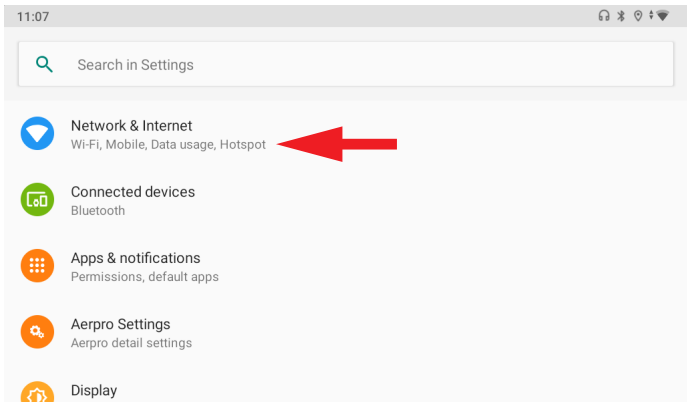
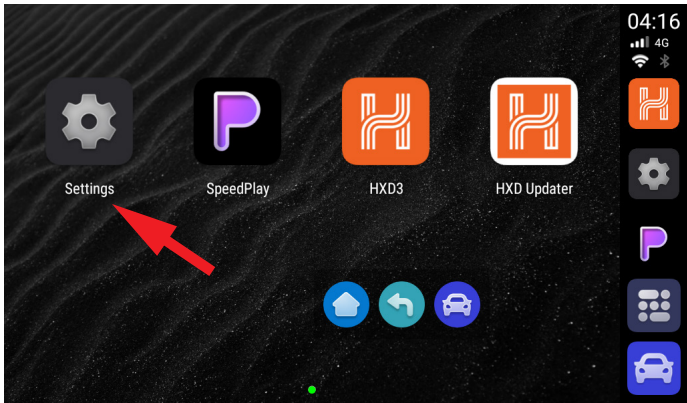
NOTE: We generally still recommend that if you are not using Hema Maps through the AMHXD3, then you disconnect the device from the car and use the Headunits CarPlay or Android Auto as we cannot guarantee full functionality when using SpeedPlay and Hema Maps at the same time.



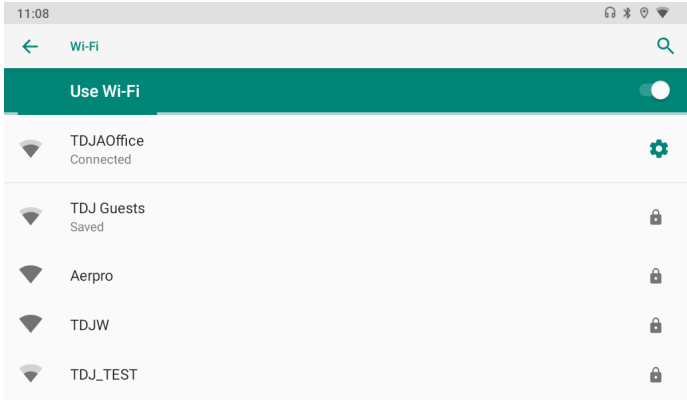
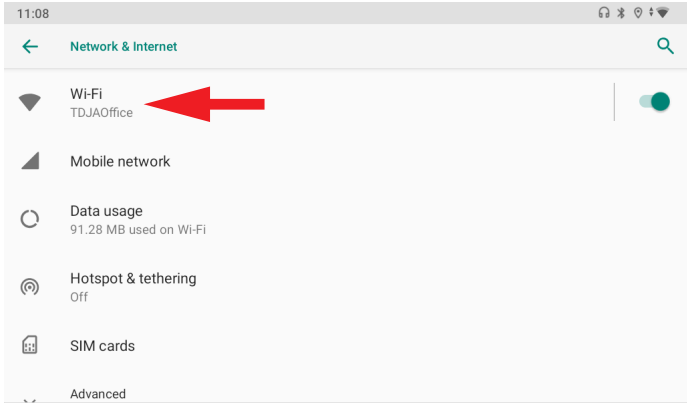
Connecting To Wi-Fi

Note: A network connection is required in order to use network features etc. (Connecting to the internet via Wi-Fi or Mobile Data using a sim card, the time and date should automatically sync with the internet).

1. Tap Settings icon
2. Navigate to 'Network & Internet'
3. Tap 'Wi-Fi'
4. Choose a Wi-Fi name and input your password to connect to your Wi-Fi network.

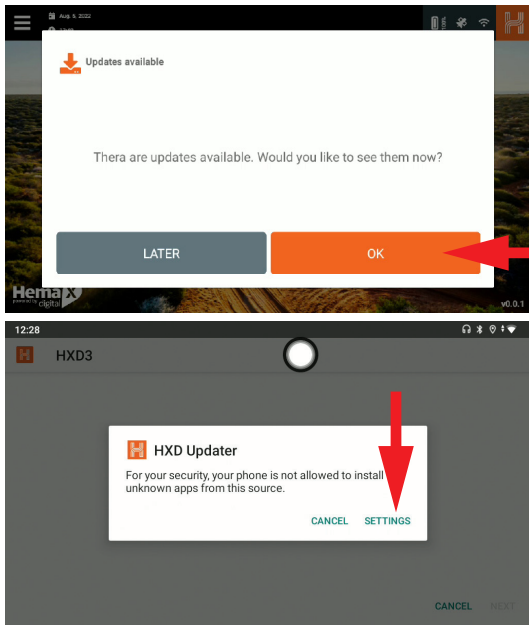


Updating Hema Maps software

Using HXD updater

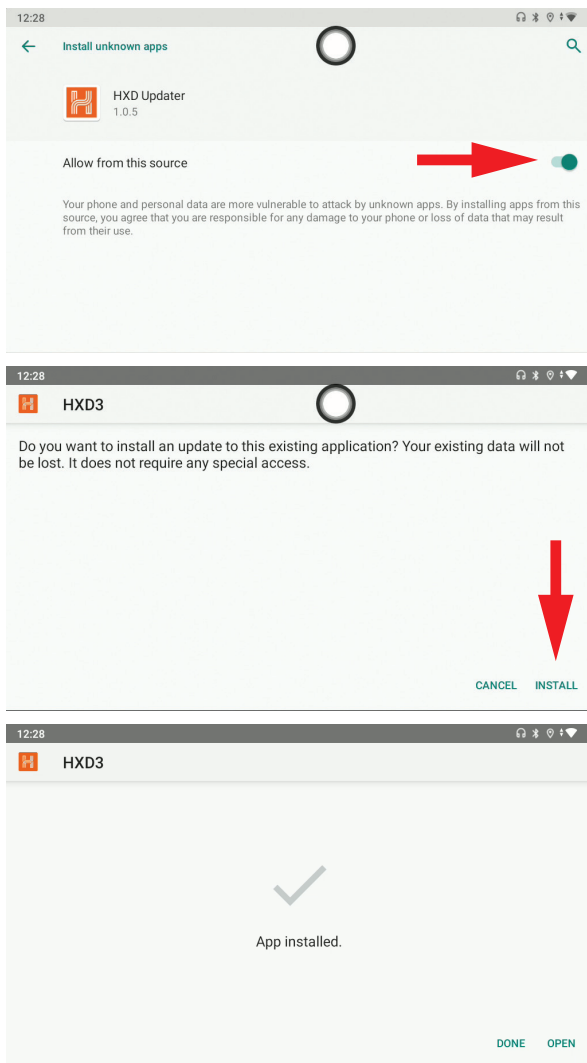
Internet connection required to receive software updates

1. If a Hema Maps software update is made available for your AMHXD3 you will be presented with a pop up dialog asking if you would like to update your software. Clicking OK will bring you to the HXD Updater. You can also tap the Updater icon in the Hema Home screen or the HXD Updater application on the AMHXD3 Home screen
2. If this is the first time you have updated the software you will be presented with an option to go to the settings to allow the HXD Updater to install apps. (This option will only need to be done once)
3. Enable 'Allow from this source' then press the back button in the top left corner
4. Then you can continue the installation by clicking install.
5. Once completed you will be presented with the option to either open the app or tap done and return to the previous screen.

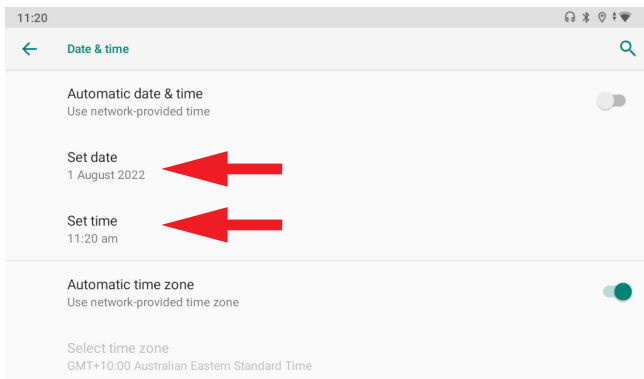
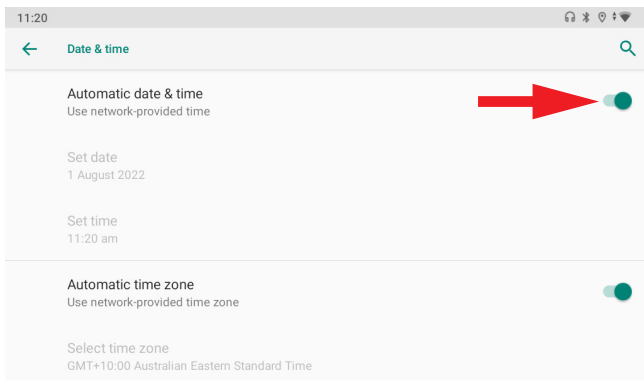
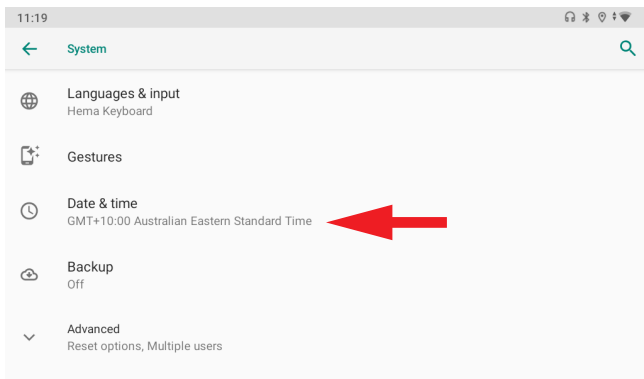
Adjusting Date/Time

Note: You will only need to do this if you do not have an internet connection and the date & time is incorrect.

1. Tap the 'Settings' icon in the home screen
2. Navigate to the bottom of the settings page and tap 'System'
3. Tap 'Date & time'
4. Turn off 'Automatic date & time' in order to manually set the date and time of your AMHXD3.

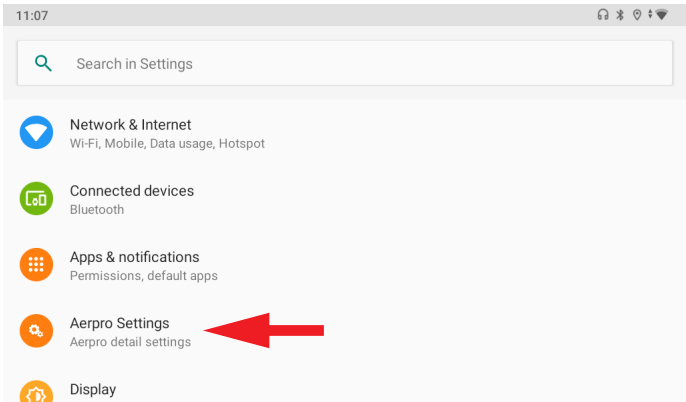
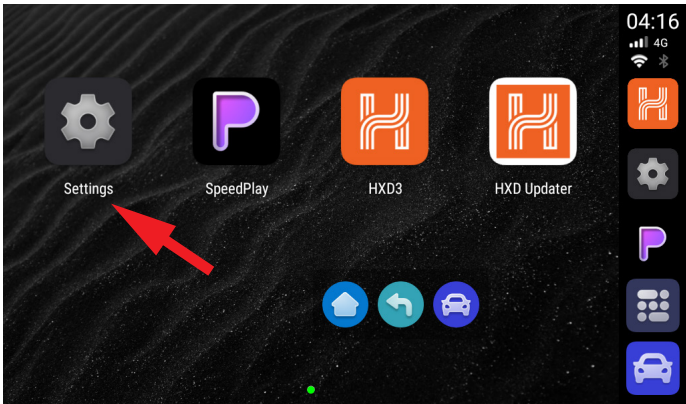


Bootup APP

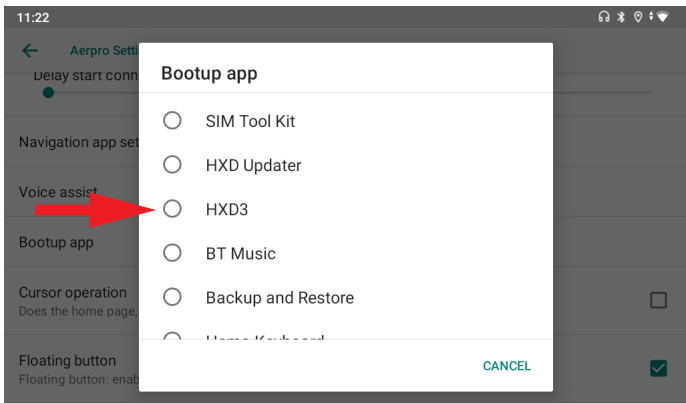
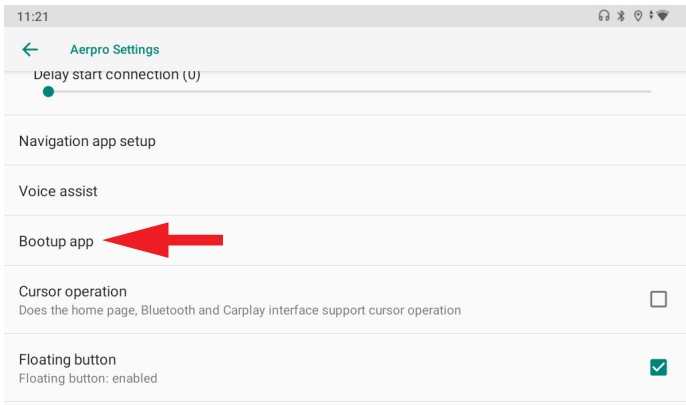
Note: This setting allows you to select an application that will start up automatically when the device boots. If you would like to automatically open Hema Maps on boot up follow the steps below.

1. Tap 'Settings' icon on the home screen
2. Navigate to the 'Aerpro' Settings section
3. Scroll down and tap 'Bootup App'
4. Scroll down until you see 'HXD3' and select it.

Now, when the AMHXD3 restarts, the device will automatically start Hema Maps on vehicle startup.

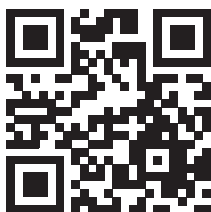

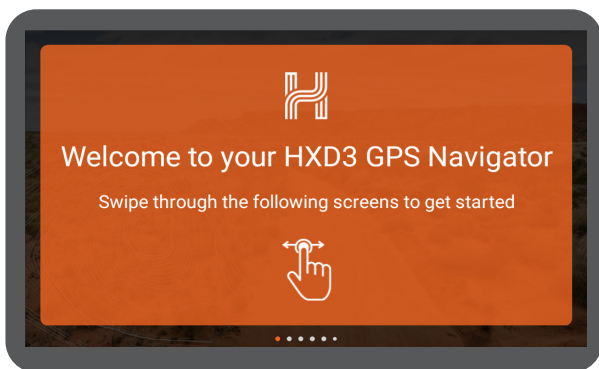

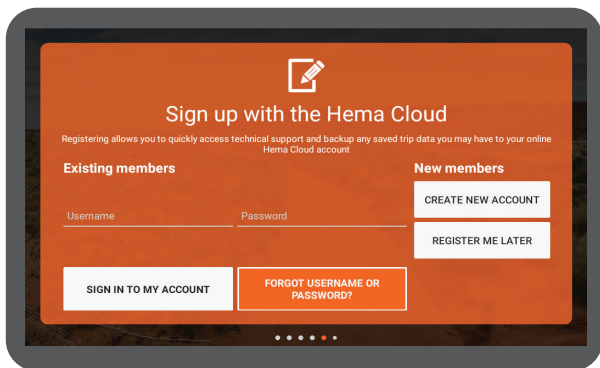


Registering your AMHXD3: The first time you switch on your AMHXD3 you will be guided through the setup process by a setup wizard. This will help connect your AMHXD3 to the Internet and allow you to sign in to or create your Hema Cloud account.

The Hema Cloud account grants you access to connect your AMHXD3 to the cloud.hemamaps.com services including trip planning, track recording, personalised waypoints & POIs and syncing your information across multiple devices.

Important: The AMHXD3 does need an initial Internet connection to set the correct date and time to register.

Signing in from your AMHXD3

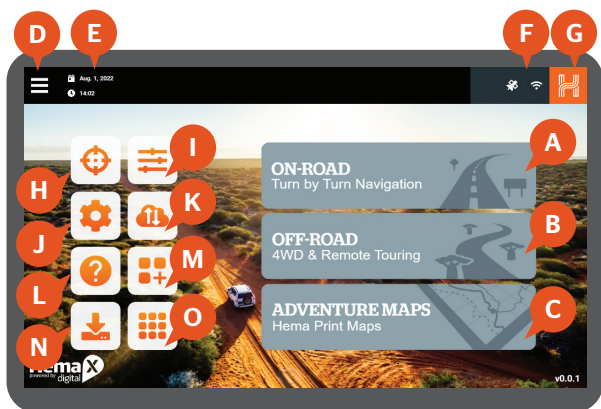


It is highly recommended you sign into your AMHXD3 via a registered Hema Cloud account, as signing in will allow you to receive regular updates and support for your AMHXD3, to back up and share trip data, and to unlock premium map content and navigation features available to you.

If you choose to not register your AMHXD3 with a Hema Cloud account, you will not have access to synchronise your recorded tracks or saved trips across your devices. You will also restrict your access to premium map and content updates available through your Hema Cloud account.

NOTE: 1) By signing up for a Hema Cloud account you are accepting the AMHXD3 and Hema Cloud account terms and conditions and the Hema Maps Pty Ltd Privacy Policy
2) You can initiate the setup process again from the tutorial menu at any time in order to register a new Hema Cloud account or you can login using existing Hema Cloud account credentials.
3) An existing HX-1 Explorer account is not compatible with the AMHXD3. You will need to transfer your Explorer account to the new Hema Cloud account via <https://cloud.hemamaps.com/migrate/start>

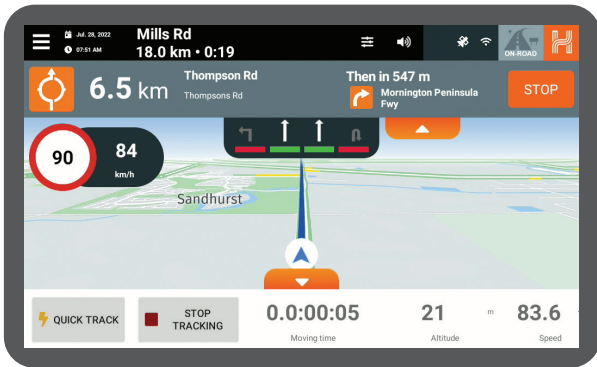
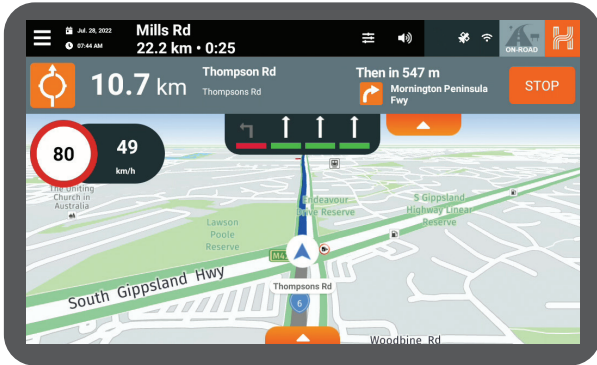

If You use the Hema Software, You will be bound by these Terms & Conditions of Use. The Hema Software (“the Software”) is licensed, not sold, to You for use only under the terms of this license. It contains warranty and liability disclaimers which You should read.

The Software and the Data are copyrighted works, protected by law, violation of which may result in civil or criminal liability. Access to the Software requires you to have internet access. Internet services may not be available at your present or intended location or may be very expensive.

1. Scope of Licence granted

1. Subject to the usage rules and restrictions in clauses 2 and 3, we grant You a non-exclusive, non-transferable license to:

- a. Use the AMHXD3 licence and Software thereon;
